## 2. Approval of Agenda

## 3. Approval of Minutes of March 11, 2019 Annual General Meeting

#### 4. Season to date (2020)

- Switched back to Cycling BC for insurance this year
- Less reliant on ride leaders
- Improved insurance coverage for members
- End of June CBC came up with guidelines on how to ride safely in a group, our first club ride was in July as a result
- Max 11 people at one ride this season
- Less highway traffic earlier in the summer
- One social in June with 7-8 people
- We have chosen not to continue indoor spin classes at Meadow Park due to the limit of 6 people per room, and same room rental fee (\$800) for MPSC. We can re-evaluate mid-winter if there is interest and COVID-19 is not a threat.
- We gave morning rides (mid-week) a try with no change in number of riders

#### 2019

• Turnout was highest in May, June and early July, then drops off later in the summer

# 5. Financial statements (2019)

## 2020

Net loss of \$750 this year

Membership revenue significantly lower for 2020, but this will be offset but savings on insurance

# 6. Bylaw amendment 1 regarding quorum at board meetings
